1. You have agreed that you have read the Release and Waiver of Liability, Assumption of Risk and Indemnity agreement, fully understand its terms, understand that you have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by Law.
2. You acknowledge that motor sport is dangerous and accidents can and do happen and you have entered and remain at the Winton Motor Raceway entirely at your own risk at all times.
3. You acknowledge that you shall at all times whilst on the premises be subject to the directions of Winton Motor Raceway Management and their Agents as well as have respect for areas and facilities on the premises which you have access.
4. You will provide the management of Winton Motor Raceway Pty. Ltd. A copy of your Public Liability Certificate of Currency to the value of \$10,000,000. Winton Motor Raceway Pty. Ltd., Benalla Auto Club Inc. are to be named on the Certificate of Currency
5. Tyre changing equipment to be used in the area as specified by Winton Motor Raceway Management. Tyre changing equipment is not permitted to be used in garages or carports.
6. All electrical wiring and leads must have been tested and tagged and be labelled accordingly, showing the date of testing and date the items are to be retested.
7. Equipment brought onto the property in relation to the operation of the tyre changing machine must not be bolted or affixed to the floor under any circumstances.
8. A bond of \$100.00 is to be paid in advance to cover the use of the facility for the weekend, and other costs such as the supply of power etc. A fee of \$15 per tyre will be charged for every tyre left behind.
